In connection with the monthly distribution payment of \$0.1085 per share payable on January 29, 2021 to shareholders of record on January 15, 2021, it is anticipated that 44% of such distribution will be a return of capital.

A return of capital may occur, for example, when some or all the money that you invested in the Fund is paid back to you. A return of capital distribution does not necessarily reflect the Fund's investment performance and should not be confused with 'yield' or 'income'. All amounts are expressed per common share.
