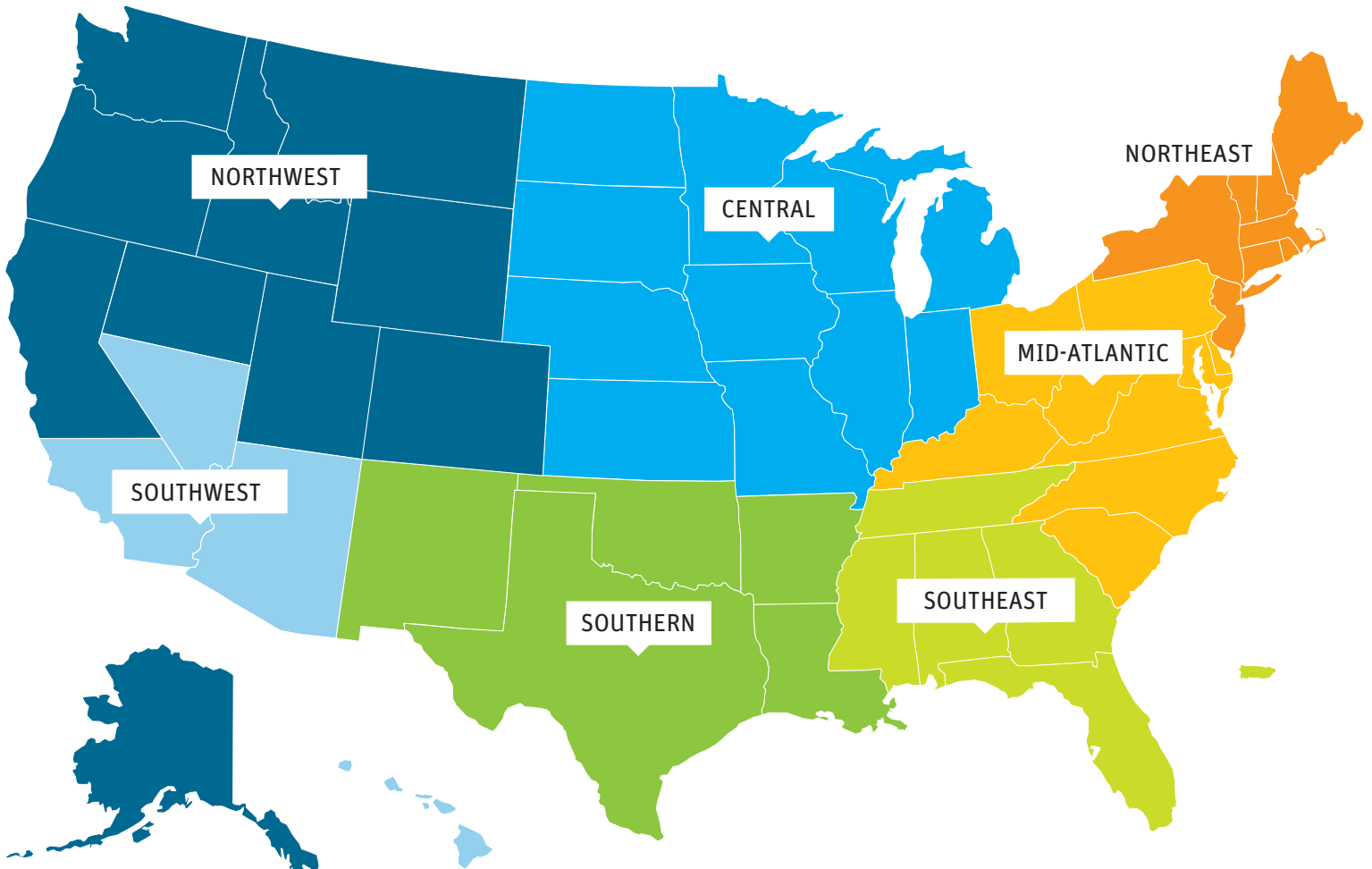


Broker-Dealer Territory Map
